Project aim	Ensuring timely and efficient treating of admitted patients at RMH through the provision of advanced practice Fibreoptic Endoscopic Evaluation of Swallowing (FEES).
Key outcomes	 Over the first five months since implementing the FEES service at RMH, 25 FEES procedures were performed, which is 3.1 times more procedures than were performed over a seasonably comparable period of 2014. Extrapolated over 12 months, this indicates a throughput of the clinic of 60 FEES procedures per year, significantly improving access to this procedure for inpatients and outpatients with dysphagia at RMH. Clinic data also indicates that patients were typically complex, with multiple comorbidities, and that half were from regional or interstate areas and almost a quarter were from Non-English Speaking Backgrounds, where there are known barriers to accessing a
	 range of services such as FEES. At least one case clearly documented of the FEES procedure directly preventing an acute hospital admission for aspiration pneumonia. There was also a case whereby access to the FEES outpatient clinic allowed a patient to be discharged home instead of waiting 2 days for an inpatient videofluorscopy .This is estimated to improve patient flow by creating additional capacity of up to 27 acute bed days per annum.

	• An analysis of the projected input and output costs of the project show a significant cost- benefit to sustaining this training program alongside the FEES clinic, to the order of approximately \$35,000 per annum.
